Re: EMCS Whale Tale Film Production, 2020

Trust you are all managing well personally during these challenging times. Sincere thanks for all your ongoing efforts in serving students, parents and the community at large.

I'm taking this opportunity as chair of the EMCS Society 'Tale of the Whale' documentary film working group to inform you about this unique project. We are also wondering whether there might be any funding available through SD #62 to help partially cover our modest costs. An overview of the project and a rough working budget are attached below.

Naturally none of us involved in the working group expect an answer any time soon, but we do hope you'll keep us in mind when things return to a semblance of normal. I'll be sure to remind you of this request at that hopefully not too distant time. If you require a more formal request for funding, please advise.

### **The Project**

At the suggestion of EMCSS board member Loretta Rose Deutscher, the Society is creating a short (15 to 20 minute) documentary that will tell the story of how a whale skeleton found its way into Sooke's new community school and hangs to this day above the commons, sparking curiosity and wonder in students and visitors alike.

The film will be based in large part on the warm and colourful recollections of Phoebe Dunbar, a full-time SD #62 employee from 1987-98. She was the force of nature who took the lead with the whale skeleton starting in 1989 and did so much to create enduring links with the community preceding, during and following the new school's construction.

Using new and archival footage, the documentary will tell a story about the EMCS family, Sooke's culture and the engagement of the community in this one epic and meaningful undertaking. It's web of associations will include natural history, Sooke's marine environment, our coastal First Nations (T'Sou-ke, Scia'new and Pacheedaht) and the community school's unique curricula.

Our working team has included **Phoebe** herself; EMCS Society cocoordinator **Sasha Gale** and now her pregnancy leave replacement**Ashley Green**; educator, academic and storyteller **Elizabeth Lange**; former Global News Parliamentary Hill cameraman **Frank Antonsen**; former SD #62 multimedia instructor **Dal Little**; and **myself** and **Loretta** as board representatives.

We are seeking a former or current EMCS student to be the film's narrator.

We have respectfully approached T'Sou-ke Chief Gordon Planes regarding his and the First Nation's participation in the film. Our planned interview subjects include Chief Planes; former trustees and EMCS Society staff and board members; the architect who used the skeleton as inspiration in the school's design; and members of the maritime community who volunteered for the sinking, flensing, raising, storing and transporting of the skeleton.

### The Ask

Specifically, we are asking for consideration of \$3,000 to provide honorariums to the professionals involved in this production and our TBD narrator, the costs of scanning historical photos and converting VHS archival material; and other miscellaneous costs.

Prior to leaving on pregnancy leave, Sasha did some serious digging for grant monies and the EMCS Society office is waiting to hear back from a variety of local and provincial organizations. Others of our team are looking into possibilities of funding through the National Film Board's Filmmakers Assistance Program and the Knowledge Network Producers' Fund. A Community Grant request has been submitted to the District of Sooke.

We are seeking SD #62's support in creating an inspiring film that showcases and records a vital and fascinating aspect of the new school's development. We are doing this now since, as Loretta suggested in her original proposal, it would be wonderful to capture the memories of many of the key players and inspirational leaders involved before they move away or pass on.

### Board Info Note Public Board Meeting April 28, 2020

**Agenda Item: 9.1 Catchment Review: Guiding Principles** 

**Background:** Over the past few months, the members of the Consultation Group, who were assigned to review catchment and boundary changes, has met to discuss the Board Policy and other aspects that may relate to catchment review. The context that was followed included:

- Policy F-502 "School Catchment Areas and Student Placement", allows the Board to review catchment areas "as required"
- The School Act, section 75 (1) and (2) says that "a board must establish for each school … a catchment area …". Therefore, we are required by legislation to establish catchment boundaries for new schools.
- Part of the process will require extensive public consultation.
- The catchment review process will take into consideration future school expansions in order to minimize impact to student transitions

Recently we consulted with the community through **thoughtexchange** on the following question: "What do you think the Sooke School District should consider when creating and adopting new catchment boundaries?"

The common themes that emerged as possible guiding principles from the following sources: thoughtexchange, Senior Executive and Catchment Area Consultation Group members were:
