





### Subject: BC's Bill 40 - The School Amendment Act and the new Provincial Ministerial Order on IECs

I am writing you today regarding the Province's Bill 40 - The School Amendment Act, the new Ministerial Order on Indigenous Education Councils (IEC) and their implications for Métis families and students.

As you are aware, Bill 40 mandates the establishment of Indigenous Education Councils (IECs) across all school districts in our province. These councils are intended to influence and engage in decision-making processes that impact Indigenous students' educational experiences in the BC K-12 public system.

The Ministerial Order stipulates that, in establishing an IEC, a board must consider the distinctions and diversity among the Indigenous student population served by the board, ensuring that the composition of the IEC reasonably reflects the Indigenous student population. Several districts across British Columbia have Indigenous student populations that include Métis students, including SD62 Sooke.

In previous conversations with your Indigenous Education department, we have been advised that you have **361 Métis** students. Our Citizenship Registry and Métis family connections program enrolment confirm a Métis student population.

We recognize that SD62 Sooke has a long standing and commendable relationship already established with <u>Métis Nation of Greater Victoria Association</u>, we are excited to see the



good work done on behalf of our children continue. Individuals from this community are best suited to identify a representative to bring Métis perspectives to the IEC.

In the spirit of friendship and reconciliation, MNBC is committed to walking respectfully alongside T'Sou-ke Nation, Sc'ianew Nation, Pacheedaht Nation, Esquimalt Nation, Songhees Nation, SD62 Sooke Board of Education, and other partners representing Urban Indigenous learners, for the benefit of all students. MNBC looks forward to connecting on this important matter to determine how we can grow our partnership and best support our children at these newly established IECs.

Agenda Item: 7.1 - Major Capital Update

#### **Background**

• Staff would like to provide the Board with an update on the District's current major capital projects

#### Sooke Elementary

- The updated Project Definition Report (PDR) has been submitted to the Ministry of Education & Child Care (MoECC)
- The intent of the revisions was to explain the cost difference between a seismic upgrade and a full replacement (preferred option)
- Staff anticipate the PDR will be reviewed by Treasury Board once their meetings start up after the election

#### North Langford Secondary School

- Through a Request for Proposals (RFP) process, staff have selected HCMA Architects to develop the Project Definition Report (PDR)
- HCMA designed Royal Secondary, PEXSISEN and Centre Mountain Lellum for the District
- The first step in the process is to create a site layout map to see how the components of the school (building, parking lot, fields, childcare, etc.) can fit on the site
- Staff are working with the Village Initiative to determine the Neighbourhood Learning Centre (NLC) space requirements based on their community needs assessment
- It is anticipated that the PDR will be submitted to the MoECC in late fall or early winter

#### Port Renfrew Elementary (PRE) Seismic Project

- The District continues to work with the Pacheedaht First Nation (PFN) in the replacement of Port Renfrew Elementary based on the Nation's desire to create a K-12 campus in community
- The final designs of the new school are being finalized and should be ready shortly

#### DC and RK Pre-Fabricated Classrooms

- Construction at both Ruth King and David Cameron continue with the final push to occupancy in full flight
- Staff and the contractor are focusing on life safety issues in order to receive occupancy by school start-up
- As with most large capital work, this project's tight timelines (approval received in October 2023) has resulted in schedule challenges

#### SC'IA'NEW STEŁITKEŁ

- Consistent with the pre-fab classrooms noted above, construction at SC'IA'NEW STEŁITKEŁ is on schedule and budget
- All of the mass timber is on site and installed as the contractor now prepares to finish the roof in time for the fall
- The field will be planted shortly and is expected to be ready for school start-up in September 2025

## Board Info Note Public Board Meeting August 27, 2024

Agenda Item: 9.1 – 2024/25 Enrolment Update

#### **Purpose:**

Provide the Board of Education with a preliminary snapshot of the 2024/2025 enrolment trends.

#### Background:

Tracking and projecting student enrolment is a dynamic process, particularly when considering the added complexity of Sooke District's accelerated growth, the health of local, provincial and national economies, and the continued increase of newcomer families to our region. Preliminary enrolment trends confirm growth in enrolment across the district and in all grade levels. Numbers are variable at this early stage as we confirm students and families who are leaving, arriving and moving between schools.

There are four trends that we are closely monitoring as we move towards the end of September and the Ministry 1701 enrolment count:

- 1. Year to Year Growth: How much has our enrolment increased as compared to September 2023?
- 2. Summer Growth: How much did our enrolment increase from end of school year to the final week of August 2024?
- 3. Budget impacts: How do current numbers compare to the projected enrolment that informed our 2024/25 Budget?
- 4. Current enrolment & available space: Will we have enough room to accommodate all students?

#### **Analysis:**

- a) Year to Year Growth
  - We projected a September standard enrolment of 13,065 for students K-12. In addition to this, we will see students registered in Alternative Education, Online learning, Adult Learning, and International fee-paying.
  - This is a 300-400 increase in standard enrolment from September 2023. At this time, we are on track for meeting, and likely exceeding, the target number of 13,065.
- b) Summer Growth
  - Summer growth kept to a similar pace as the summer of 2023 with approximately half of the almost 200 registrations being at the elementary level and the remainder divided between middle and secondary.
- c) Current Enrolment Budget Impacts
  - Current enrolment trends have us within the preliminary budget and on track for appropriate staffing levels with no additional budget pressures.
- d) Current Enrolment & available space
  - Currently, we have the space to accommodate the projected registrations for September 2024.
  - We will continue to monitor our growth over the course of the year and have necessary space mitigation strategies in place.
